As per the reference above, the following Inter District Transfer and Postings of LPSA /UPSA (Malayalam) are ordered with immediate effect. The transferee is not eligible for T.A. and joining time.

The Transferee will be assigned rank on Junior to Junior most in the category of teachers working in this district. A declaration to this effect should be obtained and pasted in the service book of the transferee concerned and necessary entries to this effect should be recorded before they are relieved from their duties. The teacher transferred under G.O. (MS) No. 94/2003, dated: 23/4/2003 are not eligible for transfer other than Hill area schools for five years. Heads of school concerned should ensure that no application for transfer to such teachers contrary to this provision is forwarded to the Deputy Director of Education. If it is found that a transferee under G.O. (MS) No. 94/2003, dated: 23/4/2003 has submitted application for transfer other than hilly or remote area school before 5 years of transfer, disciplinary action will be initiated against them and the Inter District Transfer will be cancelled.

Necessary entries regarding the Inter District Transfer should be recorded in the service book of the teacher concerned under proper attestation. If the teacher has already been transferred from the school noted in this order, this order should be communicated to the school in which the transferee is now working under intimation to this office. Discrepancies and errors if any noticed may be intimated to this office

The Heads of schools concerned will report the date of relief and admission to duty in due course. The transferee should join duty in the school concerned on or before **27/07/2016.**
